What Is The BCMA Contingency System?

A tool to maintain the availability of time-critical medication administration data to clinicians in the event of a planned or unplanned VISTA or network downtime.

BCMA Contingency Relies On

- Inpatient Pharmacy
- Kernel
- HL7

BCMA Backup Features

- Updated via HL7 messages from VISTA, a real-time inpatient record is maintained on contingency workstation
- Unidirectional with built-in potential for bidirectional communication
- Provides 3-7 day Medication Administration Record (MAR) and Medication Administration History (MAH) info to screen or printer
- Multidivisional support
- NEW PERSON synchronization



What Is The Backup Used For?

Planned or Unplanned downtime

- Ability to look at inpatient med orders for the past, current and pending activity
- Ability to print out a MAR worksheet for medication administration

What Is The Backup Used For?

By placing a box in the Pharmacy, the Pharmacy staff would have the ability to look at the same inpatient medication activity as the wards.

What Is The Backup Used For?

By placing a box in a location accessible to providers, they would also have the ability to look at inpatient medication activity during system down time.

Security Issues

Multiple Levels of Security:

- Windows/Linux log-on
- VISTA log-on

V/STA sign-on security synchronized with NEW PERSON information from production V/STA

VISTA option security keys

Future Enhancements

Bi-directional functionality

- Data entered on the Contingency workstations will automatically update the VISTA system when it is back on-line.

- GUI interface for the workstation
- Expanded to include additional clinical data on the Contingency workstations
